All 2 Yr. Old Bulls have passed semen test with the exception of lot 49 that sells subject to retest (close to testing OK). All yearling bulls will be tested prior to delivery. Any yearlings picked up on sale day will need to be tested, and APEX will reimburse @ \$30/head to the buyer.

Complete calf and annual herd vaccination plus worming protocol is done as recommended by veterinarian. All sale lots have been poured with Clean Up II within the last 30 days. Bred heifers have received Guardian scour guard vaccine.

All females have been officially calfhood vaccinated (OCV).

All fall bred cows are 100% pregnant to the AI service as confirmed by 1/24 ultrasound!

Lots 119 and 134 EPDs are ASA pedigree estimates as DNA still in process, pedigree is guaranteed accurate.

Calves at side of fall cows will be registered and transferred, their catalog EPDs represent ASA pedigree estimates.
